DELIVERY METHODS

WEB DELIVERY

The normal method of delivering EASE and EASE JR and their associated modules is by download from a secure website. You will need a high speed (cable modem, DSL or better) internet connection capable of handling 50 MB program and 200 MB loudspeaker data files.

HARD COPY DELIVERY

Program CDs and a hard copy of the Tutorial manual are also available for a nominal fee (\$35.00) plus shipping charges. (Import duties, local taxes and brokerage fees are the responsibility of the purchaser.) For shipments within the USA allow \$7.50 for UPS Ground and \$35.00 for overnight service.

TERMS AND CONDITIONS

LICENSING POLICY

EASE, EASE JR, EARS and AURA are open format software programs intended for use by acoustical consultants, design engineers, contractors and others engaged in the design, installation, or analysis of electro-acoustic systems.

The programs are available to all individuals and organizations engaged in the foregoing activities with no restrictions.

LICENSES

The license fees for EASE, EASE JR, AURA and EARS cover the program's installation and simultaneous use on 2 (two) or 4 (four) PC's. Owners of 2-user key and 4-user key licenses may add additional user keys in sets of two for the prices shown on the previous page.

Use of the software programs is ongoing with no fixed termination or renewal date. There is no annual or bi-annual renewal fee.

The initial license fee covers and includes:

1. The complete software package which includes the latest releases of EASE, EASE JR, EARS and AURA, including loudspeaker acoustical performance and physical data files from all loudspeaker manufacturers participating in these open format programs.
2. A complete Tutorial manual. (Available for download in PDF form on the Renkus-Heinz website, www.renkus-heinz.com, or as a printed document if ordered separately.)
3. Ongoing e-mail, telephone or fax software support.

LIMITATIONS

1. EASE, EASE JR, EARS and AURA licenses are subject to all the normal laws and restrictions governing the use and sale of software. Details are provided with the software or are available in advance on request.

2. EASE & EASE JR are open format data base programs containing loudspeaker data from all loudspeaker manufacturers who have provided ADA or Renkus-Heinz with acoustical performance and physical data on their products. Renkus-Heinz and ADA accept no responsibility for the accuracy of the data submitted.

COMPUTER REQUIREMENTS

EASE runs under Windows 2000, Windows XP, Vista and Windows 7 operating systems on PC's with a VGA graphics system. Windows 95 is not supported and Windows ME (Millennium) is not recommended.

Minimum recommendations call for a machine with 256 MB or more of RAM, 600 MHz or higher clock speed and at least 2 gigabyte or more of hard disk space (EASE requires a minimum of 600 MB of hard disk space.) Higher clock speeds and larger 512 MB or even larger RAMs are highly recommended for advanced users. Microsoft .NET Framework v2.0 is also required.

EARS requires a full duplex stereo sound card to fully utilize its capabilities.
